

## ORDINANCE 2016-05

**AN ORDINANCE TO APPROVE THE CONTRACT OF SALE BETWEEN KINGCO, INC. AND THE TOWN OF KINGSTREE AND TO AUTHORIZE THE MAYOR AND CLERK TO EXECUTE SAID CONTRACT OF SALE AND PARTICIPATE IN CLOSING.**

**WHEREAS**, the Town of Kingstree has negotiated a Contract of Sale with Linda L. Harrington and J. M. Lavender of KINGCO, Inc. whereby the Town is seeking to purchase a lot of land adjacent to the Town Hall property for the sum of \$10,000.00 in order for the Town to have additional space for the expansion of emergency services (fire and police), and


**WHEREAS**, the funds to be used for the purchase of said property shall be financed by the sale of bonds.


**BE IT ORDAINED**, by the Mayor and Council of the Town of Kingstree, South Carolina, in Council assembled and by Authority of the same:

**PASSED AND RATIFIED IN COUNCIL**, duly assembled the 28<sup>th</sup> day of July, 2016, and shall become effective immediately.


