

## ORDINANCE 2017-06

**AN ORDINANCE TO AMEND §51.45 TO PROVIDE FOR AN INCREASE IN WATER RATES TO BEGIN AUGUST 1, 2017, AS SET FORTH BELOW:**

**WHEREAS**, the Town of Kingstree wishes to increase the water rates; and

**WHEREAS**, the Town of Kingstree needs to amend §51.45 to provide for an increase in the fees for Water Rates effective as of August 1, 2017, and **NOW THEREFORE**,

**BE IT RESOLVED** that the Town of Kingstree hereby amends §51.45 to provide an increase in the fees for water rates effective as of August 1, 2017, as follows:
