

ORDINANCE 2018-13

AN ORDINANCE TO AMEND §50.35 TO PROVIDE FOR AN INCREASE IN GARBAGE AND TRASH COLLECTION RATES EFFECTIVE SEPTEMBER 30, 2018, AS SET FORTH BELOW:

WHEREAS, the Town of Kingstree needs to amend §50.35 to provide for an increase in the fees for Garbage and Trash Collection Rates effective as of September 30, 2018, and **NOW THEREFORE**,

BE IT ORDAINED, by the Mayor and Council of the Town of Kingstree, South Carolina in Council assembled and by Authority of the same:

That the Town of Kingstree hereby amends §50.35 of the Town of Kingstree Code of Ordinances to provide for an increase in the fees for Garbage and Trash Collection rates effective as of September 30, 2018, as follows:

§50:35 FEES ESTABLISHED:

A. Garbage and trash collection fees are hereby amended as follows:

Small Commercial Business	\$ 21.00 per month	
Large Commercial Businesses		
(1) 4 cubic yard containers:		
one pick up per week	\$ 40.00 per month	
two pickups per week	\$ 73.00 per month	
(2) 6 cubic yard containers:		
one pick up per week	\$ 53.75 per month	
two pickups per week	\$ 79.75 per month	
(3) 8 cubic yard containers:		
one pick up per week	\$ 67.50 per month	
two pickups per week	\$100.50 per month	


All other applicable statues, ordinances and DHEC regulations will apply.
